ACQUISITION OF THE HAEMOTRONIC GROUP, INTEGRATION OF THE PRESS RELEASE ISSUED TODAY

Zola Pedrosa (BO), May 13, 2022 - GVS S.p.A. ("**GVS**" or the "**Company**"), in addition to what was communicated today regarding the acquisition of 100% of the share capital of the Haemotronic Group ("**Haemotronic**"), a specialized producer of components and bags for the medical sector with plants in Italy and Mexico, specifies that the acquisition will be cash & debt free and therefore the Enterprise Value is € 212 million. The 2021 consolidated and proforma adjusted Ebitda is expected to be approximately 20% of FY2021 turnover (70.4 million euros).


